- Delivery Of Goods
 Delivery of the Goods shall be made to the Buyer's address and at the Buyer sexpense. The Buyer shall make all arrangements necessary to take delivery of the Goods whenever they are tendered for delivery, or the Goods shall be delivered to the Buyer at
- If the Seller fails to deliver or makes defective delivery of all or part of the Goods this does not entitle the Buyer to cancel the 62
- contract.
 When the Goods at the date of this agreement are in possession of a third person there is no delivery by the Seller to the Buyer unless and until such third person acknowledges to the Buyer that the Goods are being held on behalf of the Buyer subject to the issue or transfer by the Seller of documents of title to the Goods. 6.3

- Risk
 If the Seller retains property in the Goods nonetheless all risk for the Goods passes to the Buyer on delivery.
 If any of the Goods are damaged or destroyed prior to property in them passing to the Buyer, the Seller is entitled, without prejudice to any of its other rights or remedies under these terms and conditions (including the right to receive payment of the balance of the Price for the Goods, to receive all insurance proceeds payable in respect of the Goods. This applies whether or not the Price has become payable under these terms and conditions. The production of these terms and conditions by the Seller is sufficient evidence of the Seller's rights to receive the insurance proceeds without the need for any person dealing with the Seller to make further enquiries. The Seller will apply the insurance proceeds as follows: first, in payment of the Price of the Goods that are damaged or destroyed, if unpaid; second, in payment of the outstanding Price of any other Goods supplied to the Buyer by the Seller whether under the terms and conditions or otherwise;

- third, in payment of any other sums payable to the Seller by the Buyer on any account, fourth, any balance is to be paid to the Buyer.

- Return Of Goods

 Except as provided in this clause, the Buyer is not entitled to return the Goods to the Seller for any reason. For defective Goods which the Buyer is entitled to reject, the Seller's liability is limited to either (at the Seller's discretion) repairing or replacing the Goods, or refunding the Price provided that:
 the Buyer must notify the Seller within 14 days of delivery that the Goods are defective;
 the Seller is given a reasonable opportunity to investigate the Buyer's claim;
 the Seller will not be liable for Goods which have not been stored or used in a proper manner; and
 the Seller will not be liable to pay the Buyer any amount more than the amount (if any) the Seller received from the supplier for the

Defects
The Buyer shall inspect the Goods on delivery or installation and shall within fourteen (14) days of delivery or installation notify the
Seller of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Buyer shall alford
the Seller an opportunity to inspect the Goods and installation within a reasonable time following delivery, if the Buyer shall alia for
comply with these provisions the Goods shall be conclusively presumed to be in accordance with the terms and conditions and free from any defect or damage

- Warranty
 The warranty period is (unless a different period is agreed to in writing) three (3) months on repairs to Goods.
 The terms and conditions, time limits and other warranty information for Goods sold to the Buyer will be supplied to the Buyer by the Seller when all accounts are paid in full. The Warranty shall be the current warranty provided by the manufacturer of the product. The Seller shall be under no liability whatsoever except for the express conditions as detailed and stipulated in the manufacturers warranty.
 We will not be liable to repair any defective Goods and at our own discretion we may: notify the manufacturers of the Goods of any defect notified by you; and request the manufacturers to repair or replace any defective Goods.

Consumer Guarantees Act 1993

This agreement is subject, in all cases except where the Buyer is contracting within the terms of a trade/business (which cases are specifically excluded), to the provisions of the Consumer Guarantees Act 1993.

- Default & Consequences Of Default
 Interest on overdue invoices shall accrue at such a rate after as well as before any judgement.

 (b) The Buyer has met all other obligations due by the Buyer to the Seller in respect of all contracts between the Seller and the Buyer, and that the Goods, or proceeds of the sale of the Goods, shall be kept separate until the Seller shall have received payment and all other obligations of the Buyer are met.

 Until such time as ownership of the Goods shall pass from the Seller to the Buyer the Seller may give notice in writing to the Buyer to return the Goods or any of them to the Seller. Upon such notice the rights of the Buyer to obtain ownership or any other interest in the Goods shall cases.

 If the Buyer fails to return the Goods to the Seller than the Seller or the Seller's agent may enter upon and into land and premises owned, occupied or used by the Buyer, or any premises as the invitee of the Buyer, where the Goods are situated and take possession of the Goods, without being responsible for any damage thereby caused. Receipt by the Seller of any form of payment other than cash shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised and until then the Seller's ownership of rights in respect of the Goods shall continue.

 The Buyer shall not charge the Goods in any way not grant por otherwise, give any interest in the Goods while they.

 The Seller can issue proceedings to recover the Price of the Goods sold notwithstanding that ownership of the Goods may not have passed to the Buyer.

- 14. Personal Property Securities Act 1999

 14.1 Upon assenting to these terms and conditions the Buyer acknowledges and agrees that:

 (a) These terms and conditions constitute a security agreement for the purposes of section 36 of the Personal Property Securities Act 1999 ("PPSA"); and

 (b) A security interest is taken in all Goods previously supplied by the Seller to the Buyer (if any) and all Goods that will be supplied in the future by the Seller to the Buyer during the continuance of the parties relationship:

 (e) immediately advise the Seller of any material change in its business practices of selling the Goods which would result in a change in the nature of proceeds derived from such seles.

16. Cancellation
16.1 The Seller may cancel these terms and conditions or cancel delivery of Goods and Services at any time before the Goods are delivered by giving written notice. - 18. Unpaid Sellers Rights To Dispose Of Goods

 20.5 The Seller may license or sub-contract all or any part of its rights and obligations without the Buyer's consent.
